**ORDINANCE NO. 9341**

**AN ORDINANCE CREATING A NEW FUND (FUND #217) FOR THE CITY OF  
HAMMOND POLICE DEPARTMENT FOR VIDEO RECORDING FUNDS**

WHEREAS, House Bill 1019 is currently scheduled to become law on July 1, 2016; and

WHEREAS, House Bill 1019 allows for a copy fee for recordings and allows the agency collecting the fee to spend the fee for certain purposes including additional police recording equipment ; and

WHEREAS, the City of Hammond must now have a new fund established for receipt and distribution of these funds; and

WHEREAS, Heather Garay, City Controller, requests that a new account, number 217 be dedicated and created for the City of Hammond Police Department for purchasing cameras and other equipment from the funds received from these fees and this fund shall exist so long as monies are available; and

WHEREAS, the creation of this fund is not an additional appropriation and a public hearing is not required;

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond that the Hammond City Controller be and is authorized to provide, dedicate and create a new account for the City of Hammond as follows:

**CITY OF HAMMOND #217 VIDEO RECORDING FUND**

BE IT FURTHER ORDAINED by the Common Council that this Ordinance shall be in full force and effect from and after its passage by the Common Council, signing by

the President thereof and approval by the Mayor and approval of the DLGF.
