**A RESOLUTION AUTHORIZING THE CITY OF HAMMOND, BY THE HAMMOND
FIRE DEPARTMENT, TO APPLY FOR A 2015 HOMELAND SECURITY FOUNDATION
GRANT**

WHEREAS, the Hammond Fire Department, due to age and wear and tear, needs new gas carbon monoxide monitors and EMS “jump bags” to be used for public safety; and

WHEREAS; the City of Hammond, by its Fire Department, is eligible to apply for a Four Thousand Dollar (\$4000.00) reimbursement grant for this equipment, which means the City of Hammond would purchase this equipment and be reimbursed up to \$4000.00; and

WHEREAS, the City of Hammond and the Hammond Fire Department require the Approval of the Hammond Common Council to apply for this grant; and

BE IT THEREFORE RESOLVED, by the Common Council of the City of Hammond, that the City of Hammond, by and through the Hammond Fire Department is authorized to apply for a Four Thousand Dollar (\$4000.00) reimbursement grant to be used to purchase new gas carbon monoxide monitors and EMS “jump bags.”

BE IT FURTHER RESOLVED by the Common Council of the City of Hammond that this resolution shall be in full force and effect from and after its passage by the Common Council, signing by the President thereof and approval by the Mayor.
