WHEREAS, the Congress of the United States has enacted and the President of the United States has signed into law on August 22, 1974, Public Law 93-383, the "Housing and Community Development Act of 1974"; and

WHEREAS, the primary objective of this program is the development of viable urban communities by providing decent housing and a suitable living environment and expanding economic opportunities principally for persons of low and moderate income; and

WHEREAS, it is the intention of Congress that the federal assistance made available under this program not be utilized to reduce substantially the amount of local financial support for community development activities below the level of such support prior to availability of assistance hereunder; and

WHEREAS, it is necessary and in the public interest that the City of Hammond, Indiana avail itself of the financial assistance provided by Title I of the Housing and Community Development Act of 1974, as amended, to commence a Community Development Program within the City of Hammond.

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the
City of Hammond, Indiana that;

1. The United States of America and the Secretary of Housing and Urban Development be, and hereby are, assured of full compliance and administration of Civil Rights Act, citizen participation, equal opportunity, relocation payments, affirmative action, acquisition processes, accounting processes, the Hatch Act, minimum wage and minimum hours provisions of the Fair Labor Standard Act, and requirements of the National Environmental Policy Act of 1968.

2. The Mayor the City of Hammond, Indiana is authorized and directed to prepare an application for the 2019 grant (year ending March 31, 2020) and to execute the proposed programs including all understandings and assurances contained herein as provided in this Resolution.

3. Applications on behalf of the City of Hammond for grants up to \$2,720,248.00 of said Title I funds and for the purpose of seeking Title II funds as specified by the application's Consolidated Plan is hereby approved and that the Mayor of the City of Hammond is hereby authorized to execute and file such application with the Federal Department of Housing and Urban Development, to provide such additional information and to furnish such documentation as may be required of said Department and act as the authorized correspondent of the City of Hammond relating to the Community Development Program.

5. Any and all funds received under the above application shall be expended only in strict compliance with all applicable federal laws and regulations, and, upon appropriation thereof by the Common Council.


