

MINUTES
BOARD OF PUBLIC WORKS AND SAFETY
JULY 30, 2015

The regularly scheduled meeting of the Board of Public Works & Safety convened at 9:03 a.m., in Council Chambers of Hammond City Hall. A roll call was taken: Mr. Krusa - present; Mr. Dostatni –present; Mr. Smith – present.

Motion by Mr. Dostatni to defer approval of the minutes of the meeting of July 30, 2015; seconded by Mr. Smith. AYES ALL. Motion carried.

Supplemental Agreement No. 3 received from First Group Engineering, Inc. for the Kennedy Avenue Road Reconstruction project – 174th Street to 169th Street. Mr. Dostatni said there is no change in cost of the project but the labor rates have changed. Motion by Mr. Dostatni; seconded by Mr. Smith. AYES ALL. Motion carried. (Ins. No. 15-755)

Supplemental Agreement No. 2 received from First Group Engineering, Inc. for the Marquette Greenway project – Phase 3 Sheffield Avenue from 129th Street to the Toll Road. Motion by Mr. Dostatni; seconded by Mr. Smith. AYES ALL. Motion carried. (Ins. No. 15-756)

Agreement received from First Group Engineering, Inc. for the Grand Marquette Trail – 143rd Street and Calumet Avenue to Grand Calumet River submitted for approval. Contract with Fire Services, Inc. for the purchase of three (3) 2016 F350 crew cab pickups with up fit packages. Motion by Mr. Smith; seconded by Mr. Dostatni. AYES ALL. Motion carried. (Ins. No. 15-758)

Proposal received from Bellsom Electric to furnish the material and perform the labor necessary to . Mr. Dostatni said the cost of this work will be \$27,000. Motion by Mr. Dostatni; seconded by Mr. Smith. AYES ALL. Motion carried. (Ins. No. 15-759)

Correspondence received from Chief of Police John Doughty requesting approval of Office Rogers to receive CBO Specialty Pay effective October 14, 2015 and the promotion of Officer B. Motion by Mr. Smith to waive the late fee for 2015 and assess rental registration at \$5 per unit; seconded by Mr. Dostatni. AYES ALL. Motion carried. (Ins. No. 15-762)

Order to Rescind Order to Demolish property located at 3331 176th Place, 4605 Henry Avenue and 6122 Ray Avenue submitted for approval. Ms. Kantar said the three (3) properties had previously been on the demolition list. Motion by Mr. Smith; seconded by Mr. Dostatni. AYES ALL. Motion carried. (Ins. No. 15-763)

Agreement to Rehabilitate Property Located at 1133 River Drive (garage only) submitted for approval. Ms. Kantar said this is a bank owned property and the bank will pay for repairs. Motion by Mr. Smith; seconded by Mr. Dostatni. AYES ALL. Motion carried. (Ins. No. 15-764)
