Change Order No. 22 and 23 received from American Structurepoint, Inc. for the 169th Street Reconstruction Project. Mr. Dostatni advised Change Order No. 22 is an increase of \$2,079 for a change in the quantity of materials and Change Order No. 23 in the amount of \$4,438.39 for modification of striping in the project.
