## MINUTES BOARD OF PUBLIC WORKS AND SAFETY FEBRUARY 21, 2013

The regularly scheduled meeting of the Board of Public Works & Safety convened at 9:03 a.m., in Council Chambers of Hammond City Hall. A roll call was taken: Mr. O'Connor –absent: Mr. Dostatni – present; Mr. Lendi – present.

Due to the absence of Mr. O'Connor, normal rules of procedure are suspended.

Recommendation by Mr. Dostatni to approve the minutes of the meeting of February 7, 2013 and defer approval of the minutes of February 14, 2013; Mr. Lendi concurred.

Correspondence received from Mr. Nicholas E. Wojcicki requesting the Notice of Violation hearing held last week be reheard as he was not present. Recommendation by Mr. Lendi to vacate findings of February 14, 2013 and reset this matter for March 14, 2013; Mr. Dostatni concurred. (Ins. No. 13-162)

Correspondence received requesting rental registration hearings on property located at 1828 Indianapolis Boulevard, 3958 Wabash Avenue,  $1510 - 170^{\text{th}}$  Street and 4931 Walnut Avenue. Recommendation by Mr. Lendi to set these matters for March 21, 2013; Mr. Dostatni concurred. (Ins. No. 13-163)

Rental registration hearing on property located at 529 Vine Street. Property owner fails to appear. Recommendation by Mr. Lendi to deny the appeal and assess a \$500 late fee plus rental registration at \$80 per unit; Mr. Dostatni concurred. (Ins. No. 13-164)

Rental registration hearing on property located at 4904 - 06 Ash Avenue. Property owner fails to appear. Recommendation by Mr. Lendi to deny the appeal and asses rental registration at \$80 per unit with a \$500 late fee; Mr. Dostatni concurred. (Ins. No. 13-165)

Rental registration hearing on property owned by Ms. Juanita Cisneros. Property owner, Ms. Juanita Cisneros, appears. Ms. Cisneros stated she has owned the two (2) unit building since 2000 and her children have lived there until the end of 2012. Recommendation by Mr. Lendi to waive the late fee and assess rental registration at \$80 per unit; Mr. Dostatni concurred. (Ins. No. 13-166)

Rental registration hearing on property owned by Mr. Martin Landeros. Property owner, Mr. Landeros, appears. Mr. Landeros state he has owned the property since 2011 and that he forgot to pay the registration fee, his tenants have not been paying rent as they have become unemployed. Recommendation by Mr. Lendi waive the late fee for 2013 and assess rental registration at \$80 per unit; Mr. Dostatni concurred. (Ins. No. 13-167)

Mr. Matt Saliga, Inspector, Inspections Department, advised the Restriction on Use of Property has been signed on 1822 Davis Avenue but the property owner for 4437 Cedar Avenue has not yet signed. Recommendation by Mr. Dostatni to sign 1822 Davis Avenue and defer 4437 Cedar Avenue; Mr. Lendi concurred. (Ins. No. 13-168)

Amusement Device Listing for the week of February 19, 2013. Recommendation by Mr. Lendi; Mr. Dostatni concurred. (Ins. No. 13-169)

Mylar for the Autozone Rolling Mill Addition to the City of Hammond. Mr. Dostatni advised the Plan Commission signed and approved the Mylar on February 16, 2013. Recommendation by Mr. Dostatni; Mr. Lendi concurred. (Ins. No. 13-170)
