Property owner appears, said his puppies destroyed a notebook that had dates of things that needed to be paid and did not received notice it was due. Mr. Prieto said both 2017 and 2018 were not paid. Ms. Garay said there may be some confusion on the property owner's address. Garage Sale Permits submitted for approval. Motion by Mr. Margraf; seconded by Mr. Long. AYES ALL. Motion carried. (Ins. No. 18-280)

Under Meeting Opened to the Public, Mr. Prieto brought Mr. Barraza who had failed to appear at a rental registration hearing set for March 29, 2018 and had been assessed a late fee for two (2) properties, 7539 Madison Avenue and 937 Becker Street. Mr. Barraza said that he lives at 937 Becker Street and rents 7539 Madison Avenue. Mr. Prieto said only 2017 has not been paid and there are no issues with the property.
