Mr. Rodriguez appeared and said that he will get insurance with a rider naming the City if there are injuries as he would like to have a bounce house, the Board is made up of volunteers, and he would like Kennedy Avenue from 167<sup>th</sup> Street to 169<sup>th</sup> Street blocked for the festivities after the parade which would include a beer garden. Ms. Garay advised Mr. Rodriguez to obtain a permit to sell liquor from the county first and then the beer garden request would have be approved by the Park Board. Ms. Kantar asked Mr. Rodriguez if the NWI Puerto Rican Committee, Commonwealth of Puerto Rico was registered as a not for profit group

with the state. Mr. Rodriguez said that the committee is for profit this year and would be a not for profit group next year. Mr. Rodriguez then said he has a Certificate of Assumed Business Name which is filed in Crown Point. Ms. Garay asked if Mr. Rodriguez had a bank account and if so, whose name was it held in. Mr. Rodriguez said that he has a bank account in his name for the Committee. Motion by Ms. Garay to refer this matter to the Law Department; seconded by Mr. Margraf. AYES ALL. Motion carried. (Ins. Correspondence received from H.U.G.S. requesting permission to extend the parade route to Hessville Park and hold festivities at the park. Under Meeting Opened to the Public, Ms. Susie Urbine asked the Board how long she can stay in one (1) place while selling flowers on Mother's Day if she has a Peddler's License. Mr. Margraf suggested she contact Hammond Police Chief Doughty to determine the length of time.

Ms. Donna Crozier then requested a dead tree be removed from the easement of 7211 Oakdale Avenue. Mr. Margraf said tree removal requests must be done by contacting the Park Department.
