BOARD OF PUBLIC WORKS AND SAFETY MINUTES OF JUNE 2, 2016

The regularly scheduled meeting of the Board of Public Works and Safety convened at 9:01 a.m. on Thursday, June 2, 2016, in the Council Chambers of Hammond City Hall. A roll call was taken: Mr. Dostatni - present; Ms. Garay -absent; Mr. Margraf- present.

Due to the absence of Ms. Garay, normal rules of procedure are suspended.

Correspondence received from AT&T requesting permission to perform work behind 3831 Hohman Avenue. Recommendation by Mr. Margraf; Mr. Dostatni concurred. (Ins. No. 16-384)

Request for Termination of Agreement for environmental remediation with Witham's SAV-A-STOP, 7452 Indianapolis Boulevard, submitted for approval. Recommendation by Mr. Margraf; Mr. Dostatni concurred. (Ins. No. 16-385)

Property owner appears and said the property was not rented until September of 2015 and it was an oversight the fee was not paid. Recommendation by Mr. Margraf to waive the late fee and assess rental registration at \$5 per unit for 2016; Mr. Dostatni concurred. (Ins. No. 16-395)

Rental registration hearing on property located at 4850 Catalpa Avenue. Property owner appears and said she was ill during the time rental registration was due. Ms. Kantar said this is a single family home and there have been no police calls. Recommendation by Mr. Margraf to waive the late fee and assess rental registration at \$5 per unit for 2016. Mr. Dostatni concurred. (Ins. No. 16-396)

Rental registration hearing on property located at 6933 McCook Avenue and 7416 McCook Avenue. Property owner appears by property manager, Ms. Lynn Huber. Ms. Huber said the property was bought by the owners on October 2, 2015, 6933 McCook Avenue has never been rented, will be put on the market tomorrow and she lives at 7416 McCook Avenue as part of her salary Recommendation by Mr. Margraf to have the property owner complete an Affidavit for both properties; Mr. Dostatni concurred.
