<u>MINUTES</u> BOARD OF PUBLIC WORKS AND SAFETY JUNE 5, 2014

The regularly scheduled meeting of the Board of Public Works & Safety convened at 9:01 a.m., in Council Chambers of Hammond City Hall. A roll call was taken: Mr. Krusa – present; Mr. Dostatni – present; Mr. Smith – present.

Motion by Mr. Dostatni to approve the minutes of the meetings of May 1, 2014 and May 8, 2014 seconded by Mr. Smith. AYES ALL. Motion carried.

Mr. Smith requested Attorney William Padula address the Board. Mr. Padula requested the Business License Revocation hearing for his client Gold Rush be continued. Motion by Mr. Smith to continue this matter to July 17, 2014; seconded by Mr. Dostatni. AYES ALL. Motion carried.

Hearing on property located at 584 Sibley Street. Attorney Curtis Vosti appears for property owners. Mr. Matt Saliga, Inspector, Inspections Department, appears for the City. Mr. Vosti stated that he has requested discovery which he has not received from the Inspections Department. Mr. Vosti then said the City has requested this property be a two (2) unit property, instead of the four (4) unit it currently is. Mr. Saliga stated the Board affirmed the Findings and Order on February 16, 2014 and those findings should stand.
