## BOARD OF PUBLIC WORKS AND SAFETY MINUTES OF JUNE 13, 2019

The regularly scheduled meeting of the Board of Public Works and Safety convened at 9:00 a.m. on Thursday, June 13, 2019, in the Council Chambers of Hammond City Hall. A roll call was taken: Ms. Garay – absent; Mr. Margraf – present; Mr. Long – present.

Due to the absence of Ms. Garay, normal rules of procedure are suspended.

Recommendation by Mr. Long to defer approval of the minutes of the meeting of May 23, 2019; Mr. Margraf concurred.

Correspondence received from LTS Managed Technical Services LLC requesting permission to place underground fiber optic cable on Columbia Avenue and 169th Street to Columbia Avenue and 175th Street to 175th Street to Northcote Avenue. Recommendation by Mr. Long; Mr. Margraf concurred. (Ins. No. 19-384)

Correspondence received from Mr. Jose Jaramillo requesting rental registration hearings set on two (2) dates, June 20, 2019 and July 11, 2019, be heard on one (1) date for both properties. Recommendation by Mr. Long to set both matters for hearing on July 11, 2019; Mr. Margraf concurred. (Ins. No. 19-411)

Rental registration hearing on property located at 7536 Chestnut Avenue. Property owner appears and said he did not know there was a specific due date to pay by. Mr. Jaime Prieto, Commissioner, Code Enforcement, said there are no issues with the property and the property owner has not yet paid for 2019. Recommendation by Mr. Long to waive the late fee and assess rental registration at \$5 per unit for 2019; Mr. Margraf concurred. (Ins. No. 19-412)

Rental registration hearing on property located at 6127 Columbia Avenue. Property owner, First Church of the Nazarene, appears by a representative and said he overlooked the date to pay for 2019. Mr. Prieto said only 2019 is owed. Recommendation by Mr. Margraf to waive the late fee and assess rental registration at \$5 per unit for 2019; Mr. Margraf concurred. (Ins. No. 19-413)

Rental registration hearing on property located at 6410 Maryland Avenue and 4232 Dearborn Avenue. Property owner fails to appear. Mr. Prieto advised 2018 is past due. Recommendation by Mr. Long to waive the late fee and assess rental registration at \$5 per unit for 2018; Mr. Margraf concurred. (Ins. No. 19-414)

Rental registration hearing on property located at 5512 Beall Avenue. Property owner fails to appear. Mr. Prieto advised that a hearing was held for non- payment of rental registration from 2013 through 2016 and late fees were not waived. Recommendation by Mr. Long to assess the late fee of \$500 and rental registration of \$5 per unit for 2018; Mr. Margraf concurred. (Ins. No. 19-415)

Rental registration hearing on property located at 6530 California Avenue. Property owner appears, said he bought the property in the summer of 2018 and owns six (6) other properties in the City. Mr. Smith requested this matter be continued. Recommendation by Mr. Long to continue this matter to July 11, 2019; Mr. Margraf concurred. (Ins. No. 19-416)

Rental registration hearing on property located at 4609 Pine Avenue. Property owner appears and said he came on the last day to pay but was too late as the office was closed. Mr. Prieto said there are no issues with the property. Recommendation by Mr. Long to waive the late fee and assess rental registration at \$5 per unit for 2019; Mr. Margraf concurred. (Ins. No. 19-417)

Rental registration hearing on property located at 7514 Jackson Avenue, 6604 Jackson Avenue, 414 Florence Street and 7205 Hohman Avenue. Property owner appears, said he has never been late before and failing to register the properties "just fell through the cracks". Mr. Prieto said 7514 Jackson Avenue is a three (3) unit and the others are single family dwellings and there are no issues with any of the properties. Recommendation by Mr. Long to waive the late fee and assess rental registration at \$5 per unit for 2019; Mr. Margraf concurred. (Ins. No. 19-418)

Correspondence received requesting rental registration hearings. Recommendation by Mr. Long to set these matters for September 12, 2019; Mr. Margraf concurred. (Ins. No. 19-419)
