MINUTES BOARD OF PUBLIC WORKS AND SAFETY JUNE 20, 2013

The regularly scheduled meeting of the Board of Public Works & Safety convened at 9:00 a.m., in Council Chambers of Hammond City Hall. A roll call was taken: Mr. Lendi – present; Mr. Dostatni – present; Mr. Smith – present.

Motion by Mr. Dostatni to defer approval the minutes of the meeting of June 13, 2012; seconded by Mr. Smith. AYES ALL. Motion carried.
