## BOARD OF PUBLIC WORKS AND SAFETY MINUTES OF JUNE 21, 2018

The regularly scheduled meeting of the Board of Public Works and Safety convened at 9:00 a.m. on Thursday, June 21, 2018, in the Council Chambers of Hammond City Hall. A roll call was taken: Ms. Garay - absent; Mr. Margraf – present; Mr. Long - present.

Due to the absence of Ms. Garay, normal rules of procedure are suspended.

Recommendation by Mr. Margraf to defer approval of the minutes of the meeting of June 14, 2018; Mr. Long concurred.

Correspondence received from Mayor Thomas McDermott, Jr. authorizing \$5,200 of Mayors 2018 Gaming Funds to be allocated to Rule 5 Permit for the Pedestrian Bridge over Calumet Avenue and Conkey Street. Recommendation by Mr. Long; Mr. Margraf concurred. (Ins. No. 18-507)

Supplemental Agreement No. 3 received from Beam Longest and Neff, LLC for additional soil sampling at a cost of \$5,200 for the Calumet Avenue/Conkey Street Bridge project due to rule changes required by INDOT. Recommendation by Mr. Long; Mr. Margraf concurred. (Ins. No. 18-508)

Correspondence received from Councilman Bill Emerson, Sr. requesting \$8,000 of gaming funds be allocated for a design contract with First Group Engineering, Inc. due to an increase in the scope of work to the original contract. Recommendation by Mr. Long; Mr. Margraf concurred. (Ins. No. 18-509)

Property owner, Ms. Jennifer Stevens, said her ex-husband owned the property during the majority of those years, repairs have been made and the failure for her to pay the fee was not intentional. Recommendation by Mr. Long to assess one (1) \$500 late fee for 2013 and \$5 per unit for 2014, 2015, 2016, 2017 and 2018; Mr. Margraf concurred. (Ins. No. 18-519)

Rental registration hearing on property located at 922 Summer Street. Property owner appears with an interpreter who said the property owner just forgot to pay. Mr. Prieto said there was a hearing for 2013 - 2014 unpaid rental registration and the property owner was assessed a late fee for both years. Recommendation by Mr. Long to assess the late fee of \$500 and rental registration of \$5 per unit for 2018; Mr. Margraf concurred. (Ins. No. 18-520)

Rental registration hearing on property located at 538 Detroit Street. Property owner appears. Mr. Prieto said there are no problems with this property and 2018 is the only year due. Recommendation by Mr. Long to waive the late fee and assess rental registration at \$5 per unit for 2018; Mr. Margraf concurred. (Ins. No. 18-521)
