MINUTES BOARD OF PUBLIC WORKS AND SAFETY SEPTEMBER 26, 2013

The regularly scheduled meeting of the Board of Public Works & Safety convened at 9.05 am, in Council Chambers of Hammond City Hall. A roll call was taken: Mr. Lendi – absent; Mr. Dostatni – present; Mr. Smith – present.

Due to the absence of Mr. Lendi, normal rules of procedure are suspended.

Recommendation by Mr. Dostatni to defer approval of the minutes of the meeting of September 12, 2013; Mr. Smith concurred.

Mr. Lendi appears for the meeting. Normal rules of procedure are reinstated.
