## BOARD OF PUBLIC WORKS AND SAFETY MINUTES OF OCTOBER 10, 2019

The regularly scheduled meeting of the Board of Public Works and Safety convened at 9:00 a.m. on Thursday, October 10, 2019, in the Council Chambers of Hammond City Hall. A roll call was taken: Ms. Garay - present; Mr. Margraf – present; Mr. Long – present.

Motion by Mr. Margraf to approve the minutes of the meeting of September 26, 2019; seconded by Mr. Long. AYES ALL. Motion carried.

Request for bid dates of October 17, 2019 and October 24, 2019 with a bid opening date of November 7, 2019 for the 5th District Lighting Project – Phase 3 – Alexander Avenue from I-80/94 to 173rd Street, Marshall Avenue from I-80/94 to 173rd Street and 174th and 175th Streets from Alexander Avenue to Marshall Avenue. Motion by Mr. Margraf; seconded by Mr. Long. AYES ALL. Motion carried. (Res. No. 2845)

Request for bid dates of October 17, 2019 and October 24, 2019 with a bid opening date of November 7, 2019 for the 5th and 6th District Lighting Project – Phase 4 – Grand Avenue from 177th Street to Orchard Avenue.
