<u>MINUTES</u> <u>BOARD OF PUBLIC WORKS AND SAFETY</u> <u>OCTOBER 17, 2013</u>

The regularly scheduled meeting of the Board of Public Works & Safety convened at 9:01 a.m., in Council Chambers of Hammond City Hall. A roll call was taken: Mr. Lendi –present; Mr. Dostatni – present; Mr. Smith– present.

Motion by Mr. Dostatni to approve the minutes of the meeting of October 3, 2013; seconded by Mr. Smith. AYES ALL. Motion carried.

Contract with Superior Construction Co., Inc. for the Monon Bike Trail and Bridge Project. Motoin by Mr. Dostatni; seconded by Mr. Smith. AYES ALL. Motion carried. (Ins. No. 13-1011

Change Orders No. 11 and 12 for the Reconstruction of Columbia Avenue from Michigan Street to Chicago Street submitted by First Group Engineering, Inc. Mr. Dostatni advised there is no change in cost for Change Order No. 11 as it adds sixteen (16) additional days to the project due to the repairs performed on the water main in front of the Hammond Sanitary District and Change Order 12 is a decrease of \$2,056 due to the utilization of Type IIIA Subgrade Treatment in lieu of Type IA. Corporation Counsel Kristina Kantar advised the company misread the bid specifications and bid three (3) properties as demolishing the garage only and as a result withdrew the three (3) bids. Mr. Smith requested the Board affirm the order to demolish as this property has had no water since 2007, failing roof, fascia and soffit with attached garage in bad condition. Motion by Mr. Smith to affirm the Order to Demolish; seconded by Mr. Dostatni. AYES ALL. Motion carried.

Notice of Violation hearing on property located at 2408 Birch Avenue. Property owner fails to appear. Mr. Smith requested the Board affirm the Order to Demolish due to the condition of the vacant property. Motion by Mr. Smith; seconded by Mr. Dostatni. AYES ALL. Motion carried.

Mr. Smith advised the single story frame house is marked uninhabitable as it is infested with mice and the gutters are filled with overgrowth. Mr. Smith then requested the Board affirm the Order to Demolish. Motion by Mr. Smith to affirm the Order to Demolish; seconded by Mr. Dostatni. AYES ALL. Motion carried.

Notice of Violation hearing on property located at 4608 Hickory Avenue. Mr. Pete Arrigo appears for property owner, Mr. Merrick. Mr. Arrigo stated Mr. Merrick does not want to save the house, just time to retrieve items from the house. Mr. Smith said the multi-story frame house is open to the elements, garage and roof are in bad condition, missing siding and broken windows. Mr. Mr. Smith then requested the Board affirm the Order to Demolish. Motion by Mr. Smith to affirm the Order to Demolish; seconded by Mr. Dostatni. AYES ALL. Motion carried.

Notice of Violation hearing on property located at 4846 Hickory Avenue. Property owner fails to appear. Mr. Smith advised the multi-story frame home has boarded up doors, a bad rear porch, gang graffiti on the time, garage has a collapsing door and there is peeling paint. Mr. Smith then requested the Board affirm the Order to Demolish. Motion by Mr. Smith to affirm the Order to Demolish; seconded by Mr. Dostatni. AYES ALL. Motion carried.

Notice of Violation hearing on property located at 918 Highland Street. Property owner fails to appear. Mr. Smith said the multi-story building is a former child care building with broken windows and garbage piled in the yard. Mr. Smith then requested the Board affirm the Order to Demolish. Motoin by Mr. Smith to affirm the Order to Demolish; seconded by Mr. Dostatni. AYES ALL. Motion carried.

Notice of Violation hearing on property located at 952 Hoffman Street. Property owner fails to appear. Mr. Smith said this is the old Infinity Bar and Grill and the building was gutted without permits and the interior was never finished. Mr. Smith then requested the Board affirm the Order to Demolish. Motion by Mr. Smith to affirm the Order to Demolish; seconded by Mr. Dostatni

Notice of Violation hearing on property located at 1011 Hoffman Street. Property owner fails to appear. Mr. Smith advised this is a vacant, boarded up two (2) story residence with failing siding, a dead tree in the front year and the garage is in extremely poor condition. Mr. Smith requested the Board affirm the Order to Demolish. Motoin by Mr. Smith to affirm the Order to

Demolish; seconded by Mr. Dostatni. AYES ALL. Motion carried.

Notice of Violation hearing on property located at 4726 Hohman Avenue. Property owner fails to appear. Mr. Smith stated the two (2) story structure is boarded up, there is abandoned furniture on the porch, back yard is full of garbage, no rear stairs and the siding is falling. Mr. Smith requested the Board affirm the Order to Demolish. Motion by Mr. Smith to affirm the Order to Demolish; seconded by Mr. Dostatni. AYES ALL. Motion carried.

Notice of Violation hearing on property located at 1119 Indiana Avenue (garage only). Property owner fails to appear. Mr. Smith said the garage has a huge hole in the roof that is covered with a ripped up blue tarp, part of the side wall is missing, garage is full of garbage, open to the elements with no doors. Mr. Smith requested the Board affirm the Order to Demolish. Motion by Mr. Smith to affirm the Order to Demolish; seconded by Mr. Dostatni. AYES ALL. Motion carried.

Motion by Mr. Smith to affirm the Order to Demolish; seconded by Mr. Dostatni. AYES ALL. Motion carried.

Notice of Violation hearing on property located at 929 Murray Street. Property owner fails to appear. Mr. Smith said the frame house is boarded up, siding is failing off, porch has failed, roof is falling and the house is covered in creeping myrtle. Mr. Smith then said the garage is in somewhat better shape but boarded up. Mr. Smith then requested the Board affirm the Order to Demolish. Motion by Mr. Smith to affirm the Order to Demolish; seconded by Mr. Dostatni. AYES ALL. Motion carried.

Notice of Violation hearing on property located at 4931 Oak Avenue (two (2) properties). Attorney Tim Back appeared for the lien holder on the property and said they are trying to sell the property to an investor. Mr. Smith stated the rear house has been vacant since 2011 and is in better condition that the front house which has been boarded up since 2007 which has failing foundation and a collapsing front porch. Mr. Smith requested this matter be set for status on January 30, 2014. Motion by Mr. Smith to continue this matter to January 30,2014; seconded by Mr. Dostatni. AYES ALL. Motion carried.

Notice of Violation hearing on property located at 4940 Oak Avenue. Mr. Smith advised that Attorney Jim Foster entered his appearance and has requested a continuance on this boarded up frame structure with missing siding, a bad porch, collapsed fence, with a garage that is boarded up and overgrown. Notice of Violation hearing on property located at 2719 – 164th Street (house and garage). Property owner fails to appear. Mr. Smith said the frame house is boarded up, missing soffit and fascia, gutters are falling or missing, the fence in the back yard has failed, rear porch is overgrown and the garage is open to the elements.
