# **MAYOR'S ADDRESS**

Mayor McDermott - Thanks everybody, good to see you all. Mayor's activities over the last couple weeks. Cut the ribbon at the Ninja Action Park. It's been very successful. So successful that we got parking issues already. Which is good problem to have. But I talked to Councilman Woerpel earlier, who was in my office this morning talking about what was going on over there and we're gonna be working for the neighbors in that area. We're gonna be working real closely with Ice Kube's leadership. We are working with Ice Kube's leadership. We are gonna mark that area off a lot like we do with MLK Park, with the same concept where on one side of the street it's resident only parking. On the other side of the street there's no parking tow zone. Because we can't tolerate what happened this weekend. It was the first big weekend with Ninja Kids open and it was a big problem. And I know that Councilman Woerpel was concerned about it. So, I just wanted to point that out. So, held the Mayor's Night Out in the 4th District. Thanks to Councilman Emerson and Superintendent Scott Miller and Edison Elementary School for hosting. I thought it was real good. Had lunch with Representative Hal Slager. Uh, he's the Republican Representative from Schererville. We talked about the upcoming legislation session. I've been meeting with a lot of Reps about our upcoming session. We have a couple issues that we want to them about. Sportsplex recently hosted a Division Two Women's Volleyball Tournament, Three Conference Tournament, 38 College Women's D2 College Volleyball teams attended the tournament. All the teams stayed in Hammond, dined at our restaurants. It was a three day tournament. Highly successful. I thought it went really well. I want to commend the staff at the Sportsplex, the Park Dept., and I want to thank Dave Uran and the South Shore Convention and Visitor's Bureau. They attracted that tournament to our City and it was a huge success. So, I think that's real positive. Attended a dedication ceremony at the Hammond Marina to rename the Hammond Marina after my father. Who was Hammond's Mayor for a decade and helped build the Hammond Marina. It's now referred to as the Thomas M. McDermott Senior, Hammond Marina. So, congratulations Thomas M. McDermott Senior for an honor, I think he deserves a lot. Maybe I'm biased but thankfully he built that. If it weren't for the Marina being built, but I hate to think what the 1990's and the 2010's would have looked like in the City of Hammond. So, I was keynote speaker at the Economic Development breakfast for the Indiana Builders Home Builders Association that was held in Hammond at the Indiana Welcome Center. Hosted also by

Mayor McDermott cont. - the South Shore Convention and Visitors Bureau. I presented to the group, along with Dave Uran, and the CEO of the Convention and Visitors Bureau and Sherry Ziller, the CEO of the Regional Development Authority. Attended a public meeting in Whiting regarding the EPA Superfund cleanup of Federated Metals property and the surrounding areas. I thought it was a ... it was an introductory session. They're gonna have more sessions for the people that are affected by this or that are just inquisitive about the process that's going to take place. The EPA was there. The number of representatives, along with IDEM. The meeting was informative. It was more about the history of the site and the process that we're going through. To give you an idea of what we're talking about. It's probably, at a minimum, a decade process, decade long process. So, that was ... and there's more of meetings taking place is mostly in Whiting. I attended the Lake and Porter County Judicial Reception at the Federal Courthouse. All the judges from, basically, the First Congressional District were there. It was a really good event. It seems like Hammond's hosting a lot more of these types of events. As you all know, the Hammond Municipal Budget's before you today. I talked about that in the last meeting. If you have any questions, I'm here for that but I know we've been really busy then last couple weeks but it's been mostly focused on getting this budget before you our (unclear) meetings. I don't have anything else to discuss unless the Council has ...

Councilman Kalwinski - Good afternoon, regarding that EPA meeting, a resident in Robertsdale and a business in Robertsdale, both reported they got the flyer the day of the meeting, which is insufficient. Maybe Ron Novak can call the EPA and say that's not good notice.

Mayor McDermott - I appreciate that, Councilman. It seems like the EPA, because of what we did, which I'm proud of, that we did a lot of work on residential properties. So it seems like Hammond's residential ... first off, Whiting's problem is much bigger than ours. Numbers wise, they have more homes affected than Hammond. And we've taken care of our homeowner's through our use of our American Rescue Plan money. So, I don't think .... it seems to me, and I'm not making excuses, Councilman Mark, but it seems like the EPA is talking mostly with Whiting and we're along for the ride, but it seems like a lot of the coordinating is going on between Whiting and the EPA, and I will definitely make them aware of that.

Councilman Kalwinski - It's all the same zip code.

Mayor McDermott - Yes, sir. I agree. And I totally get where you're coming from. But I noticed also that the meetings are in Whiting. Which is no problem for most of your residents. It's across the street for a lot of them, but, you know, it seems like most of the damage was done in Whiting, it seems like the EPA is coordinating closer with Whiting. We are definitely paying attention and are along for the ride. Though I don't want you to get the wrong impression, Councilman. Any more questions?

Mayor McDermott - I know Megan's out today, unfortunately, and Tinisha's here and she is ready for all your questions if you have any issues that come up. We're ready to answer them, obviously. Tinisha's been working very closely with Megan the whole time on the City Budget, so.

Council President Rakos - She was very helpful in caucus.

# MAYOR'S ADDRESS cont.

Mayor McDermott - I have an update for gas stations. We went through a couple more. I'll give you a better update next month, or next meeting, on where we are with the gas stations. But we're going through that process right now where a number of gas stations are applying. I know a number have been approved to operate all night. Off the top of my head, 7500 block of Indpls., the gas station on that block is open. 7300 Kennedy has been approved to operate all night. I know, and I don't want to get out in front of my skis. I know those two for a fact. But there's a number ... and there's a number, surprisingly, that aren't putting in. Like the new Casey's. Not putting in. They close at midnight anyway. They're not planning on staying open at midnight. That's a policy they had company wide. And then, obviously, there's other issues that we want to talk to the Councilmen and get your feel for a couple of other areas of the city. So, there will be gas stations open after midnight after November 1st. A couple here and there for interstate travelers. I don't know if you have any other questions. And I'm gonna stay, obviously, for the budget, so.

Councilman Tyler - What's the enforcement going to look like, in terms of gas stations that don't have the exclusion that maybe they tried to stay open?

Mayor McDermott - Great question. I'm still waiting if we might get legal paperwork, I'm not sure. But I imagine on midnight on November 1<sup>st</sup>, after Halloween's over, we'll go hit the road and I imagine they'll be compliance. But if there isn't then we'll have to deal with it, Councilman. But we know right now there's gonna be a number open. I say two right now for a fact. But I know the Board of Public Works is looking at a few more within the coming weeks. Like, they're all up right now. So, there will be gas stations open after November 1<sup>st</sup>, after midnight.

Councilwoman Alexander - Just to jump in with what Councilman Barry is saying, if they happen to stay open, I guess we're asking what would be something that would happen (unclear) go in or would we also maybe send out letters to remind them that ...

Mayor McDermott - I imagine, so let's say, November 1<sup>st</sup> you go to a gas station that's supposed to be shut down and it's not. I imagine we'd probably wait 'til the next morning. It's not, like, an emergency. We're not gonna, like, go storming in. I imagine the next morning we have to do something. And if they're, like, gonna test the system then we'll have to take the next step. But hopefully that doesn't happen, Councilwoman. But, it's not like, I don't think we're gonna go barging in with the SWAT team or anything if that occurs.

Councilman Kalwinski - I want to say thank you to Megan, the Controller, for ... and her staff, for all the work that it takes to put this together. It's a volume and it's got a lot of information. I'm sure it's very difficult to collate and get it all together. So, thank you to them. As well as to all the other staffs with the budgets that they're coming out with today. The only thing I want to say about the budget is, what I usually say, and that is I have a philosophical difference regarding the gaming dollars and what I can see from this budget for '23 and 2024 is that projection is a little over \$26 million expected in gaming dollars for '23 and about \$15.7 million will be going off the top into the general fund for balancing the budget, and for 2024, that same amount is budgeted for coming off the top of gaming fund. My concern is that with Bally's opening up in Chicago, and they will have a full year in 2024 to be open, I anticipate that the Horseshoe will continue to show less revenue toward the city of Hammond and even though the amount off the top is the same, I suspect that how much we take in next year will be less than \$26 million, we're projecting for this year. So our percentages will continue to get higher regarding the monies used in the gaming fund for the general budget and less for the infrastructure that remains in the pot. Twenty years ago, when the Mayor and I started, there was \$30-35 million from gaming and most of that went into infrastructure and now it looks like, you know, we're gonna have \$10 million or so. It's a slippery slope and I think we just have to be aware that at some point if we use all this money up and don't have it set aside that we're not going to be able to pay the piper at some point. So I'm just hoping that we're more careful inheriting the use of dollars from the gaming fund in trying to keep that in place for more infrastructure improvements. Thank you.
