## MAYOR'S ADDRESS

Mayor McDermott- Hi, thanks council. It's good to see you for my first address of December. I know you have 3rd and final reading on the heavy truck ordinance today. Uh, obviously, the city administration supports that ordinance and hopes for its passage. We are working on a process right now. I know the councils heard this before but just in case for the people that weren't paying attention to the last council meeting, a color-coded system to make it easier on the truck drivers that are driving through our city as well as on the police officers that are ticketing these truck drivers driving through our city to make it completely apparent when you're on the truck route and when you're no longer on the truck route. It's a color coded system. We're working on the signage right now. We're literally talking about thousands of signs. We're going to hang around throughout the City of Hammond to make it apparent when you're on the heavy truck route, when you're not on the heavy truck route. So, we're working on that and I appreciate the council for working together with the administration to help pass higher fines for the semi drivers that are off the route. Um, we think this ordinance goes part and parcel to what we're doing with the color coded system. So, thank you for considering that. I know also up on $3^{\text {rd }}$ and final today is the city issued ID cards. This is another administration ordinance that we hope that you pass. Uh, we've seen these city issued ID cards in other cities across Indiana. They particularly help with non-documented parts of our population as well as seniors or kids that don't have drivers licenses. Anybody where it's harder to get a drivers license. This is a municipal issued ID that will help them in the city of Hammond. Uh, it could help anywhere else if they want to see a government ID. It doesn't have the power of the driver's license does. It doesn't have to give you the chance... the opportunity to drive a car but it can help you prove your residence. Uh, and people will take advantage of this. Uh, we've already talked to Clerk Golec and the Clerk's office is going to assume responsibility for this program. Uh, presuming that it's approved by the council. So, I know Clerk Golec was excited about it, we're excited about it as well and I anticipate the council's support for this also. Uh, it didn't seem like it was very controversial. When it went through $1^{\text {st }}$ and $2^{\text {nd }}$ reading. So, thank you for that. Um, also on ARP 2.0, you guys are going through ARP 2.0. Real quick, ARP 2.0 is

Mayor McDermott cont.- finishing the Robertsdale lead remediation project with another $\$ 1.5$ million. Uh, repurposing firehouse No. 2 money from the use of ARP money. Uh, we're going to pay for fire house No.2, which is located in the Robertsdale part of our city, with another mechanism. Uh, sort of how we paid for the firehouse in Hessville. We want to do a proposal similar to what w did in Hessville and originally we plan to use ARP money to finish that. So, we backed that money out of the project. Uh, and we're going to pay for that another way. Downtown Hammond reconstruction, which is second in the 3rd District, $\$ 1.6$ million extra to finish that project. That's the infrastructure project going on in Downtown Hammond. $\$ 1.8$ million extra for the new Calumet Avenue Pedestrian Bridge. It's located between Munster and Hammond in our 4th District. $\$ 1.3$ million extra for the reconstruction of JF Mahoney Dr. Didn't we back that one out Councilman Woerpel?

Council President Woerpel- That was Oxbow.
Mayor McDermott- I'm sorry you're right. \$1.3 million extra for the reconstruction of JF Mahoney Dr. \$400,000 extra for the local match for the new Hessville Bridge to get residents over the constantly stopped rail traffic that's located in the 5th \& 6th District. $\$ 1.5$ million extra for Kennedy Avenue reconstruction in Downtown Hessville the project is occurring between basically Freddy's Steakhouse and 169th. I'm very happy to say $\$ 2.1$ million for the Memorial Park infrastructure. We've worked with Councilman Barry on including that as well. And I'm happy to report, Councilman Woerpel, that we got $\$ 1$ million dollars from INDOT funding through the Community Crossing Match Grant, which is $50 \%$ State, $50 \%$ Hammond funds, and we're going to use that money to reconstruct and resurface a 177th Street. Which is east of Carlson Drive, Buffalo Wild Wings. Um, so anyway, that's an update from there. Just to give you an idea of what we've been doing on the city side over the last couple of weeks since we last spoke. We're in the process of going through a reorganization in the Public Works Department. As the council is aware, Gary Gleason, Johnny Perez, the top two in the Public Works Department along with three of the District Supervisors took the buyout. I appreciate Councilwoman Katrina for recognizing Clyde Stout who tragically passed away last week after accepting the buyout and finally retiring from the City of Hammond. He was a veteran, a marine. He worked for our city for the better part of three decades and tragically died last week. He's been battling cancer, which is why he wanted to retire. Uh, its very, very sad. But to get back to the larger point, we are going through a major change in leadership in public works. Uh, the top two spots, Gary Gleason, Johnny Perez, we've decided to replace. First off, the process we went through before we made any decisions, besides the knowledge I had to be Mayor for the last 20 years, besides the knowledge Phil Tallion's had as being Chief of Staff. We talked to Gary Gleason and Johnny Perez obviously, the outgoing bosses about who they thought should take over for him and we talked to every employee in public works and we took their advice and compiled all those notes and we came up with Felix Gonzales, who's an excellent young man. Uh, he has an opportunity if he does his job the right way to be in there a long time. He's excellent. He's in supervision already. We've agreed to tap him to be our new public work supervisor. And then number two in public works is going to be Rhonda Dowd, who is obviously a female. It's very unusual to have a female in this position. It's something I'm very proud of. Rhonda has been an excellent office manager in public works. So much so that she actually got her CDL and started driving routes. Actually, I don't think she has a CDL but she drives routes and plows snow she does it in the smaller truck so she doesn't have to do with the CDL. She's been doing this for years and she's an asset as far as on the streets as well. Uh, she knows so much about Public Works we thought it was appropriate for her.

Mayor McDermott- I thought she was going to end up in a district and as it turns out based on all of our interviews, she ended up taking over as number two. So, we have a young man, a 33 year old man, right around, and a young woman running public works. I think that's pretty cool. Both Hammond residents obviously. We still have three open supervisors spots. Now that we have our leadership team assembled, we're going to start filling the leadership spots very shortly. Obviously, I'll be in contact with the District Councilmen about your spots that are open. Right now, 3, 4, and 6 are open. So, we gave the other current supervisors the opportunity to change districts if they wanted to. I think they all wanted to stay put. So, we'll be filling 3,4 , and 6 . I'll be in touch down the road on that. Also, I had a community meeting at Clark High School. Excuse me, in Robertsdale regarding the Clark High School Fields, the housing development project that we're holding. Uh, the meeting was around 100 people or so. It's around a 2-hour meeting. It was very productive. Uh, I thought it was really one of the best meetings we've had in a long time. I walked in and I felt one way, and we weren't set in stone, which is why we wanted to meet with the community. I walked in thinking I wanted one version. I walked out and all of us were convinced that there was another version that was better. It was literally, I thought it was a really productive meeting. So, we're moving forward with that project. We got the money set aside for that and ARP. We're excited about that. Uh, there's going to be a lot of green space and a lot of nice houses. If you're interested in building a new house, I'd suggest you hold off and look at what we're doing in Robertsdale right across from the Festival of Lakes Ground. Uh, we held our holiday party and our holiday parade. Um, things went really well at the Holiday Parade. I appreciate the council and my special events team for putting it together. The holiday party was excellent. I know a lot of the councilmen were there. The only thing that conflicted with our holiday parade was the US vs. Netherlands games. We still had a decent crowd, even though it was a big game happening simultaneously. Um, and last but not least. I'm sure you're aware that there was a large verdict entered against the City of Hammond from a case that emanated from a 1981 crime that occurred in our city. Uh, obviously, we're very aware of what's going on with this case. I've been talking to a lot of lawyers lately. Um, I want to remind the council that we had a case similar to this years ago where there was a large verdict entered against the city and we ended up negotiating for a much smaller amount. I'd like the council to know that we have excellent attorneys representing the city. Uh, we don't agree with the verdict against the city. We're going to appeal this verdict and I will keep you informed. If you want to get into the real details, obviously, I can keep you in the loop. Kevin and I can meet with you but we can't do it on the record as we're doing right now. Um, it's a large verdict that was entered against the city. If you have noticed, it was right around the $\$ 25$ million dollar verdict. That's obviously very large. Uh, something we don't agree with and we are appealing and doing everything that we can to defend the city. I want to point out that I was 11 years old when this occurred. Obviously, that was a long time ago for all of us. Some of us might not... some of us weren't even born at that time and we're defending a case that happened a long time ago but we have great lawyers representing the city and we're going to get great lawyers representing us on the appeal as well. It's a very serious matter and we're taking it very seriously and you know, obviously, you all know I'm an attorney. I think this is when it pays to have an attorney for a mayor because this is a very serious matter. So, I'm sorry for the long report but we've been very busy as you can imagine. If you have any questions, I'm more than happy to answer.

Councilwoman Alexander- I just want to take the time to wish our residents a Merry Christmas and a Happy New Year. And praying that they have not only a happy holiday but those that are going through trials and tribulation, that they find peace during this holiday season.

Councilman Rakos- Yes, I'd like to express gratitude to the volunteers who came out to the area of $171^{\text {st }}$ and Maryland to help clean up an area that was vandalized and people have taken advantage of this area that they got, we were able to get a lot of garbage that accumulated over many years from people that were, basically, in an area that had no business to be in, mattresses and things like that. I appreciate they came out and... Bishop Noll students were involved, I understand, I'd like you to know HC3 and myself have been doing cleanups in Hessville for about 4, or 5 years and we have the next ones that will be coming up in May and October. So, maybe we can get together on that situation for Hessville. Thank you.

Tj Gaertig- I'm an electrician, local 697. Um, I've been coming to these to get more involved in the community and see what's going on. I've really been enjoying it so far. I've met a couple of you. So, I'd like to speak today in favor of preserving the Briar East Woodland Dunes. Councilman Rakos just mentioned it. I was at the cleanup

as well. I think it's an extremely valuable asset to Hammond. Parks and nature preserves are crucial for livable cities, green spaces provide free recreation for residents. And I don't think it should be developed.

Sashi Sekhar- I came all the way down Calumet Avenue to come to Hammond. I came here because of the Dunes. I actually grew up in Hammond. I was here until I was in the third grade. And some of my fondest memories are exploring and playing in Briar East Woods. Not having a lot of money and resources being in those woods was our playground. I was a professor at Purdue University for over 25 years. I'm currently working for Lincoln Park Zoo in Environmental Education and Animal Welfare Research. So, all in all, I want to say, what brought me back to Hammond was the woods.

Ken Rosek- Mr. Rakos stole my thunder a little. We organized the cleanup behind the town homes and the place was neglected for decades. We had a coalition of four different community organizations that worked on this project. It was Hammond Community Garden, it was the Poor People's Campaign, it was Bishop Noll High School and the Hessville Dune Dusters. We collected 27 bags of garbage and a ton of other objects. I don't know how else to put it. You've got 22 individuals who are volunteering their time coming out there and taking care of this area because they care. We can take care of all that grass for you, Mr. Rakos, that's around the lake. We have experts now that work with us cleaning and rejuvenating the forest. I was a little upset that we won't have a Mayor's Night Out in 2022. In 2020, when Mayor was running for Congress, Hessville Mayor Night Out was changed three separate occasions until we got passed the election day. We used to have them in August but they didn't mess around this year. Now, we won't get any at all in 2022. The calendar on the Gohammond website simply stated canceled. Not until numerous residents called and complained it was changed with the rescheduled date on January 4, at the Jean Shepherd Center. Has anyone seen the flyer that came with your water bill? Uh, that normally has these dates. Uh, there is no mention of the rescheduling on this on the flyer. The only thing I see that is transparent here is the deception. We are not being allowed to have a public vetting in our district.

Jack Smith- I just want to give you a little insight about myself. March 30, 2021, as I was leaving Omni Gym, I was having a heart attack, driving home. If I were to take my route home, the way I usually come, I would of turned right on 173 rd to make a left on Parrish. If there was a train there, I'd been stuck behind that train and I would not be here today to tell you what was going on. As I went down Kennedy Avenue and went to $169^{\text {th }}$, I turned right to go to my house, and, well, guess what? There was a train sitting on those railroad tracks. I am in favor of the bridge to be built. Thank you.

Mayor McDermott- Under Hammond City Ordinance, for those that aren't aware, I have the ability to intervene, and I just want to clarify something that was said by Ken that I think was unfair. Uh, first off, Mayor's Night Out is scheduled a year in advance. We assume when I schedule 6 meetings across the city, first off, in Indiana, I bet there are two mayors that do Mayor's Night Out. I'm one of them, okay? I've been doing it for 20 years. I used to do 12 a year, then we cut it back to 6 a year. Sometimes stuff comes up and I have to reschedule. I was at the last council meeting and something came up. By the way, around the same time I announced this to the council, I didn't want to get into details, but we just had a $\$ 25$ million dollar verdict entered against the city at that time and I needed to talk to people about what was going on. I felt like Mayor's Night Out could be bounced back to January. So, in 2023, we're gonna do two Mayor's Nights Out in the $6^{\text {th }}$ District. We're going to do the leftover one from 2022 and then we're going to come back around for the regularly scheduled 2023 one. I want to make that clear, okay? So, to the residents of Hessville, I love you. I drive through Hessville every single day of my life. I live right next to it and I care a lot about Hessville. So, I don't want anybody in Hessville thinking we're canceling Mayor's Night Out because we don't care for them. It's not true at all. Secondly, the reason I

Mayor McDermott cont. - support the Bridge Project is not because I hate Mother Nature. I don't hate the Dunes. I don't hate going on hikes all the time. I'm outdoors more than almost anybody I know. So, I pulled up, funny enough, I was on Apple Maps just flipping through and I was hearing people talk bad about me and I said, oh, I'm going to pull up Parrish Avenue because I want to look overhead at the area we're talking about where the bridge is going to go and as I pulled it up on Apple Maps, you can pull it up yourself. I got the latest version. I pulled in on Parrish Avenue, funny enough, on Apple Maps, the satellite shot of Parrish Avenue has a stopped freaking train. Sitting there blocking Parrish Avenue. That wasn't moving, that was parked there. That's what happens. To the residents that don't live in Hessville. These trains are part...it was only blocking Parrish here. But it usually blocks Parrish and everything east of Parrish. And we'll sit there for 4 or 5 hours, not even moving. That's what this is about. This isn't about Mother Nature. This isn't about hating the dunes. This is about the number one problem in the City of Hammond is blocked trains, in my opinion. Well, crime is a close second and reciprocity but we have a lot of problems. I get constant complaints about trains, especially from the residents of Hessville. If I have an opportunity to pay for a bridge that gets us over this perpetual problem, at somebody else's cos,t which is what we're doing. The state is paying for $75 \%$ of this bridge. I would be negligent as your Mayor if I didn't take advantage of that. So, that's what this is about. This is not hating on Mother Nature. This is not we hate Hessville. This is about being a busy mayor, doing my job. This is about taking advantage of a State that wants to pay for a bridge and get us over this problem so that people like Jack Smith don't have heart attack and die in their houses because there's a stopped train blocking all the exits to a hospital. So, thank you.

## Councilwoman Venecz- Mayor, when is Mayor's Night Out in Hessville?

Mayor McDermott- It got rescheduled to January $4^{\text {th }}$. It got bounced back 2 weeks.

## Councilwoman Venecz- Exactly.

Mayor McDermott- Between what's going on with our hospital, what's going on with the lawsuit that stemmed from 1981. I have a couple things going on besides normal holidays. So, we felt like, hey, let's just bounce this back 2 weeks. If people want to protest, they can protest on January $4^{\text {th }}$, just effectively as they could have protested this week. So, I love the residents of Hessville. Always have, always will. Thank you.

Kelly Mickey- Good evening, everyone. Uh, first forgive me. I'm a little nervous to talk. It's not something that I generally do. However, I'm very active in the community. I'm always watching on Gohammond. It's very frustrating to hear negative things about the City all the time. I understand the passion and the commitment to the area that everybody is feeling upset that's being destroyed. I get that. I get it. However, I've been a Hammond resident for 49 years. I've been a Hammond employee for 24 . I've lived in Hessville for 15 years. I would have never ever understood the train issue had I not worked car 6 , or car 7 and 8 . When somebody calls for help and you can't get to them because there's a train, it's difficult. It's difficult on your spirit. It's difficult on your soul. Then, when you get there and people don't understand why you took so long to get there, while their loved one was injured either in a car accident or their father is dying of brain cancer and he's become violent and he's torn up the house and injured people, it's frustrating. I see a simple solution to build the bridge.

Michelle Mickey- Good evening, everyone. That's a tough act to follow but proud to say that's my wife. I wanted to.. I'm an environmental scientist, and I wanted to shed some light on some of the environmental regulations that surround this whole project that have yet to be brought up. I've heard Ken speak numerous times and his whole posse of accusing everyone of hating nature, but there are federal funds involved in this project. There are state funds involved in this project and therefore, there's a whole lot of things that have to be vetted. Endangered species study, environmental impact statement, a wetland delineation, a jurisdictional determination from the US Army Corps of Engineers, and if it is in fact a regulated wetland, then they have to have a permit and then they have to discuss wetland mitigation, which is generally a one for one proposal and wetland mitigation is about $\$ 40,000$ to $\$ 80,000$ an acre. The city will have to do that. It's not negotiable. These are the federal and state regulations that are required for this project. No one hates Mother Nature, we just have to be practical. Build the bridge.

Linda Anguiano- I spent a lot of my childhood in the woods that were cut down to build Morton. There is a big impact on the environment. I have had to rush my parents to the hospital for different appointments and I have been inconvenienced with trains. But there was not any kind of public meeting, public hearing. I didn't hear Scott Rakos campaigning on this issue when he was running last time. I think that there can be a win-win situation. Right here next door in Munster, there's an underpass. This particular plan makes it a hardship for kids who are walking from Morton or walking from Scott Middle School. It is not a win-win situation right now. I think that's it great we were for the federal funding but we weren't asked about this beforehand. I think you're going to have more people getting vocal about this issue if you don't take into account their feelings. I think we should go back to the drawing board, and make everyone happy. Thank you and happy holidays.

Mayor McDermott- Just so we're on the same page about if we went back to the drawing board, and we went back and we wanted to make a tunnel. It's not going to be cheaper. It's going to be more expensive. We will go back to the very beginning, if we get approved for the federal funds. It'll be a decade added to the project. A decade of stopped trains, a decade of phone calls, a decade of inaction. That's what we're talking about. If we punt on this, Munster or Dyer or one of neighbors will gobble that money up and laugh in our face. And be happy about it. And they're not going to be sad that Hammond passed up free money. They're going to be happy that Hammond passed up free money. And we'll go back to the beginning of the drawing board and we'll and say hey we want to have a tunnel instead. And they'll say get the hell out of our office. We'll talk to you in a decade. That's what will happen. And then I'll have to face the voters. Councilman Rakos, will have to face the voters, and explain why we had a bridge completely funded, and we said, nope, sorry. We wanted a tunnel. I'm running on this. This is my issue. If the residents of Hessville, vote me out. God Bless them. They can kill this deal, okay? This is so such a no-brainer. I'm going to campaign on it and I'm going to give everybody their opportunity to vote me out on this issue because this is a no-brainer and if we're going to start,... if I have to talk to 81,000 residents every time I have to make a difficult decision, Hammond will never ever, ever move forward. If I have to talk to 81,000 people before I can make a tough decision, this job is impossible and by the way, the council, you've already dealt with this issue as I have. We've already voted. This is a state job. This is in the state ball court right now unless we pull the plug. We can pull the plug. We pull the plug. This project is dead. Congratulations, Hessville, stopped trains for a decade. That's what we're talking about.
