Correspondence received from 4th District Councilman William Emerson, Sr. requesting \$25,000 of the 2019 gaming funds be allocated to the Park Gaming fund to be used for the removal and/or trimming of dead, dying and complaint tree issues within his District. Status of the Agreement for Property Located at 40 Waltham (First Extension). Corporation Counsel, Ms. Kristina Kantar, requested this matter be continued. Motion by Mr. Margraf to continue this matter to January 17, 2018; seconded by Mr. Long. AYES ALL. Motion carried. (Ins. No. 18-1,014)

Correspondence received from Mr. Alex J. Semchuck, Precision Independent Media, LLC, requesting permission to film within the City. Mr. Semchuck present and states that he is making a b-roll footage throughout the City for a story of his generation and family and would not require any street closures. Ms. Kantar stated as long as he doesn't block any public right of way and would require permission should he need any street closures or any footage regarding City property.
