- 2. The Mayor the City of Hammond, Indiana is authorized and directed to prepare an application for the 2017 grant (year ending March 31, 2018) and to execute the proposed programs including all understandings and assurances contained herein as provided in this Resolution.
- 3. An application on behalf of the City of Hammond for a grant up to \$2,695,527 of said Title I funds and for the purpose of seeking Title II funds as specified by the application's Consolidated Plan is hereby approved and that the
