**RESOLUTION NO. R29**

**A RESOLUTION AUTHORIZING THE HAMMOND FIRE DEPARTMENT TO APPLY FOR A 2018 STATE OF INDIANA ADMINISTERED FEDERAL GRANT FROM THE STATE HOMELAND SECURITY PROGRAM (SHSP)**

WHEREAS, the Hammond Fire Department, wishes to apply for a reimbursable grant from the State of Indiana's State Homeland Security Program (SHSP); and

WHEREAS; currently a \$30,000 reimbursable grant is sought for the purposes of preparing Active Shooter Response Kits to enable the Hammond Fire department to place these kits on every department vehicle; and

WHEREAS, this grant, if awarded, would allow the Hammond Fire Department to purchase such kits from existing funds and receive reimbursement for those funds from the State; and

WHEREAS, the City of Hammond must apply for to be awarded these SHSP grant funds and the Hammond Fire Department wishes to make this Grant Application and requires the Approval of the Hammond Common Council; and

BE IT THEREFORE RESOLVED, by the Common Council of the City of Hammond, that the Hammond Fire Department be authorized to apply for a 2018 State of Indiana Administered Federal Grant from the State Homeland Security Program (SHSP) in the amount of \$30,000.00 for the purpose of preparing Active Shooter Response Kits for the Hammond EMS department.

BE IT FURTHER RESOLVED by the Common Council of the City of Hammond that this resolution shall be in full force and effect from and after its passage by the Common Council, signing by the President thereof and approval by the Mayor.
