Development Act of 1974, as amended, to commence a Community Development Program within the City of Hammond.

Applications on behalf of the City of Hammond for grants up to \$2,720,248.00 of said Title I funds and for the purpose of seeking Title II funds as specified by the application's Consolidated Plan is hereby approved and that the Mayor of the City of Hammond is hereby authorized to execute and file such application with the Federal Department of Housing and Urban Development, to provide such additional information and to furnish such documentation as may be required of the City of Hammond relating to the Community Development Program.
