**AN ORDINANCE AUTHORIZING THE CITY CONTROLLER TO TRANSFER FUNDS
FROM ONE LINE ITEM TO ANOTHER WITHIN VARIOUS CITY 2013 BUDGETS**

WHEREAS, Robert Lendi, City Controller, requests that certain non-reverting account balances be reduced and a like amounts be transferred to other accounts in the general fund; and

WHEREAS, Robert Lendi, the City Controller, has advised, and the Hammond Common Council does find, that funds are available, the transfer is necessary to dispose of unused and un-appropriated balances, that the transfer does not require the expenditure of more money than the amount set out in the 2013 budget, and that the transfers be made by proper ordinance at a regular public meeting of the Hammond Common Council; and

WHEREAS, this transaction is in compliance with I.C. 36-1-8-4 and I.C. 36-8-12.2-8 and is not an additional appropriation and a public hearing is not required; and

NOW, THEREFORE, BE IT FURTHER ORDAINED by the Common Council of the City of Hammond that the Hammond City Controller be authorized to reduce and transfer the following fund balances:
