ORDINANCE NO. 9255

AN ORDINANCE RECLASSIFYING CERTAIN LANDS IN THE CITY OF HAMMOND FOR ZONING PURPOSES AND AMENDING ORDINANCE NO. 8514 (AN ORDINANCE ESTABLISHING A ZONING PLAN FOR THE CITY OF HAMMOND INCLUDING THE REGULATIONS AND MAPS TO ADMINISTER THE ZONING PLAN IN ORDER TO PROVIDE FOR ORDERLY GROWTH AND DEVELOPMENT WITHIN THE CITY, ALL IN ACCORDANCE WITH THE COMPREHENSIVE/LAND USE PLAN, AS AMENDED) FOR THIRTEEN PROPERTIES COMMONLY KNOWN AS **ALL PARCELS FROM APPROX. 2450 TO 2720 SHEFFIELD AVENUE AND 2410 TO 2640 CALUMET AVENUE IN AND AROUND WOLF LAKE MEMORIAL PARK .**

WHEREAS, in said Ordinance the following described properties are classified as I-2 Manufacturing District:
