ORDINANCE NO. 9294

AN ORDINANCE TO ESTABLISH THE 7300-7400 BLOCK FLAGSTONE DRIVE BETWEEN 174TH PLACE AND WILSON PLACE A ONE-WAY STREET GOING NORTH AND REPEALING ANY ORDINANCES IN CONFLICT THERE TO

WHEREAS, the Common Council of the City of Hammond has received a request to establish the 7300-7400 block of Flagstone Drive from 174th Place to Wilson Place as a one-way street in the East direction and to make the same of a permanent nature.

WHEREAS, the Common Council has, upon the first and second reading of this ordinance, requested the recommendations of the Board of Public Works and Safety of the City of Hammond and the Commissioner of the Street Department, and now finds that such stop signs should be erected and made permanent in the interest of public safety.

THEREFORE BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF HAMMOND as follows:

SECTION 1:

Vehicular traffic on the 7300-7400 block of Flagstone Drive from 174th Place to Wilson Place shall be one-way in a northerly direction. Schedule II of Chapter 76 of the Code of Ordinances of the City of Hammond, which is a schedule of one-way streets and alleys in the City of Hammond is hereby amended to include 7300-7400 block of Flagstone Drive. Any ordinance in conflict with this ordinance is hereby repealed.

SECTION 2: EFFECTIVE DATE.

This ordinance shall be effective upon final passage by the Common Council, signature by the President, approval by the Mayor or override of any veto of the Mayor by the Common Council, and its publication as provided by law.
