AN ORDINANCE RECLASSIFYING CERTAIN LANDS IN THE CITY OF HAMMOND FOR ZONING PURPOSES AND AMENDING ORDINANCE NO. 8514 (AN ORDINANCE ESTABLISHING A ZONING PLAN FOR THE CITY OF HAMMOND INCLUDING THE REGULATIONS AND MAPS TO ADMINISTER THE ZONING PLAN IN ORDER TO PROVIDE FOR ORDERLY GROWTH AND DEVELOPMENT WITHIN THE CITY, ALL IN ACCORDANCE WITH THE COMPREHENSIVE/LAND USE PLAN, AS AMENDED) FOR PROPERTY COMMONLY KNOWN AS 828 114th STREET, HAMMOND (WHITING P.O.), INDIANA.

WHEREAS, the City Plan Commission of the City of Hammond, Lake County,
Indiana, having held a public hearing and on the 15th day of June, 2015, did recommend that
said above described real estate is to be reclassified from R-1U Urban Single Family
Residential to C-4 General Commercial, to construct, operate, and maintain a Liquor and
Tobacco Sales facility.
