**ORDINANCE NO. 9311**

**AN ORDINANCE CREATING A NEW FUND (FUND #208) FOR THE CITY OF  
HAMMOND FIRE DEPARTMENT FOR SPECIAL EVENT COMPENSATION**

WHEREAS, the City of Hammond firefighters often work outside events for which the fire department receives funds; and

WHEREAS, the City of Hammond Fire Department utilizes these funds for compensation for firefighters; and

WHEREAS, the City of Hammond must now have a new fund established for receipt and distribution of these funds; and

WHEREAS, Heather Garay, City Controller, requests that a new account, number 208 be dedicated and created for the City of Hammond Fire Department Special Event Compensation to use and exist so long as monies are available; and

WHEREAS, the creation of this fund is not an additional appropriation and a public hearing is not required;

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond that the Hammond City Controller be and is authorized to provide, dedicate and create a new account for the City of Hammond as follows:

**CITY OF HAMMOND #208 SPECIAL EVENT COMPENSATION FUND**

BE IT FURTHER ORDAINED by the Common Council that this Ordinance shall be in full force and effect from and after its passage by the Common Council, signing by

the President thereof and approval by the Mayor and approval of the DLGF.
