**ORDINANCE NO. 9321**

**AN ORDINANCE AUTHORIZING THE CITY CONTROLLER TO TRANSFER FROM  
ONE LINE ITEM TO ANOTHER  
(as amended)**

WHEREAS, the Common Council of the City of Hammond finds that because of circumstances which could not have been anticipated at the time the budget was adopted there is a need to transfer; and

**WHEREAS**, since the transfer does not require the expenditure of more money than the total amount set out in the Hammond Common Council's 2015 budget, the transfer may be made by proper ordinance at a regular public meeting of the Common Council, and be certified to the County Auditor.

**THEREFORE BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF HAMMOND** that the City Controller be, and he is hereby authorized to provide the account reductions and account appropriations as follows:
