## **ORDINANCE NO. 9330**

AN ORDINANCE AMENDING ORDINANCE NUMBER 9315 ALSO KNOWN AS THE SALARY AND WAGE ORDINANCE FOR ALL CITY OFFICIALS AND EMPLOYEES OF THE CITY OF HAMMOND, INDIANA OTHER THAN THOSE FIXED BY STATUTE OR BY ORDINANCE HERETOFORE ENACTED, AND FIXING THE EFFECTIVE DATE THEREOF

WHEREAS, On October 13, 2015 the City of Hammond Common Council passed Ordinance 9315. An Ordinance fixing the salaries and wages of all city officials and employees of the City of Hammond, Indiana, other than those fixed by statute or by Ordinance heretofore enacted, and fixing the effective date thereof; and

WHEREAS, Issues have arisen with the City of Hammond Park Board Members in which the salary approved in 2015 no longer remains competitive for Members of the Park Board compared with surrounding municipalities of comparable size; and

WHEREAS, such Park Board Members shall also receive a small salary stipend to compensate for the additional duties and responsibilities; and

WHEREAS, the positions of Street Light Manager and Street Light Maintenance were included in the 2016 Budget but not included in the Salary Ordinance; and

WHEREAS, the salaries for the positions of Public Works Assistant Office Manager and Redevelopment Property Manager were correctly stated in the 2016 Budget but incorrectly stated in the Salary Ordinance; and

THEREFORE BE IT ORDAINED by the Common Council of the City of Hammond, Indiana that Ordinance Number <u>9315</u> the same being known as the Salary and Wage Ordinance of the all city officials and employees of the City of Hammond, Indiana other than those fixed by statute or by ordinance heretofore enacted, and fixing the effective

date thereof is amended as follows:
