ORDINANCE NO. 9340

**AN ORDINANCE AMENDING ORD. 3456 ALSO KNOWN AS SECTION 150.026 OF
THE HAMMOND MUNICIPAL CODE AS IT RELATES TO THE COMPOSITION OF
THE BUILDING CONTRACTOR'S BOARD
(as amended)**

WHEREAS, Ordinance Number 3456 also known as Section 150.026 of the Hammond Municipal Code entitled "Building Contractor's Board of Examiners" has not been amended or updated since 1965; and

WHEREAS, the current configuration of the Board and its requirements makes it difficult to fill vacancies with Hammond residents; and

WHEREAS, it is the recommendation of the Building Department that changes be made to the member make up portion of the Ordinance but the balance of Section 150.026 remain unchanged.

NOW, THEREFORE, BE IT FURTHER ORDAINED by the Common Council of the City of Hammond that Ordinance 3456 also known as Section 150.026 (A) of the Hammond Municipal Code, be amended as follows:

Section 150.026: Building Contractor's Board of Examiners

- (A) There is hereby created a Building Contractor's Board of Examiners whose members shall be appointed on staggered two (2) year terms by the Mayor and shall consist of the Building Commissioner, one (1) licensed architect or licensed engineer, one (1) licensed building contractor, one (1) member of the building trades union, three (3) lay members who are Hammond residents, an employee of the Building Department who shall serve as the Board's secretary and one (1) member of the Hammond Common Council who is the Chair of the Building and Zoning Committee for the Hammond Common Council.**
