**AN ORDINANCE TO APPROPRIATE FUNDS WITHIN THE HAMMOND POLICE
DEPARTMENT GRANT FUND FOR 2018**

WHEREAS, The Indiana Criminal Justice Institute (ICJI) annually offers traffic safety grant money to local law enforcement agencies and Hammond received an award of these funds; and
