**ORDINANCE NO. 9402**

**AN ORDINANCE CREATING A NEW SECTION OF TITLE III, CHAPTER 32  
PERTAINING TO THE USE OF CONFIDENTIAL FUNDS BY THE HAMMOND  
POLICE DEPARTMENT**

WHEREAS, The Hammond Police Department possesses a Department General Order (#96-2) in regards to the use and reporting of confidential funds; and

WHEREAS, This General Order establishes guidelines for the acquisition, management, disbursement and utilization of confidential funds; and

WHEREAS, confidential funds are funds budgeted for the purpose of purchasing services, evidence and information relating to criminal investigations; and

WHEREAS, The Hammond Police Department designates a Fiscal Officer to acquire, manage, document and disburse these confidential funds; and

WHEREAS, the Fiscal Officer is required to maintain a ledger in accordance with the Department General Order which accounts for the confidential funds expended; and

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond that the Hammond Police Department, by its Police Chief is authorized to provide, dedicate and utilize confidential funds located within the Hammond Police Department budget, in accordance with the terms and conditions of Department General Orders concerning such funds.

BE IT FURTHER ORDAINED by the Common Council that this Ordinance shall be in full force and effect from and after its passage by the Common Council, signing by the President thereof and approval by the Mayor and approval of the DLGF.
