**ORDINANCE NO. 9403**

**AN ORDINANCE DESIGNATING THE 400 AND 500 BLOCKS OF WALTHAM AS A  
ONE WAY STREET (WESTBOUND) AND REPEALING ANY ORDINANCE IN  
CONFLICT**

WHEREAS, the Board of Works received a correspondence from Hammond, Engineering Department stating that the posted signs near Eggers Elementary School require an Ordinance that the street become one way, going Westbound, as a result of school traffic and the risk to students, in the 400 and 500 Blocks of Waltham; and

WHEREAS, the Councilman for the 3rd District was notified of request, and now wishes to make such signs permanent and enforceable under City Ordinance by the adoption of an Ordinance; and

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond that the 400 and 500 Blocks of Waltham (Westbound) become a one way street, terminating 50 feet East of Blaine Avenue, near Eggers School, and such One Way Only signs be affixed and made permanent until such time as this Ordinance is repealed.

BE IT FURTHER ORDAINED by the Common Council that this Ordinance shall be in full force and effect from and after its passage by the Common Council, signing by the President thereof, and approval by the Mayor.
