Petition for Vacation of a Alley with the Common Council of the City of Hammond, Lake County, Indiana, requesting vacation of a 20 foot portion of Alley located Northwesterly of Lot 1 and Southwesterly of Lots 1 through 9 in Belaj's Addition to the City of Hammond, Indiana; and

WHEREAS, the Common Council of the City of Hammond, Lake County, Indiana upon investigation and Public Hearing in accordance with applicable law, finds and determines that the proposed vacation will not hinder the growth or orderly development of the City of Hammond, Lake County, Indiana, or the neighborhood in which it is located or to which it is contiguous; and

WHEREAS, the vacation will not make access to the lands of any persons by means of public way difficult to inconvenient; and

WHEREAS, the vacation would not hinder the public's access to a church, school, or other public building or place; and

WHEREAS, the vacation will not hinder the use of a public way by the neighborhood in which it is located or to which it is contiguous.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF HAMMOND, LAKE COUNTY, INDIANA, THAT it is desired and deemed necessary to vacate a 20 foot portion of Alley located Northwesterly of Lot 1 and Southwesterly of Lots 1 through 9 in Belaj's Addition to City of Hammond, and more particularly described as follows:

Part of the Southwest Quarter of Section 5, Township 36 North, Range 9 West of the Second Principal Meridian, being a 20 feet wide strip of land lying Northwesterly of Lot 1 and Southwesterly of Lots 1 through 9 in Belaj's Addition to the City of Hammond, as per plat thereof, recorded in Plat Book 12, page 04 in the Office of the Recorder of Lake County, Indiana, being more particularly described as follows: Beginning at the Southerly Right-of-Way line of Summer Street and the Northwest corner of said Lot 1 in Belaj's Addition;

thence South 33° 34' 23" West, along the Northwesterly line of said Lot 1, a distance of 125.00 feet; thence South 56° 17' 30" East, along the Southerly line of said Lots 1 through 9, a distance of 261.00 feet to the Easterly line of the West 21.00 feet of said Lot 9; thence South 33° 42' 30" West, a distance of 20.00 feet; thence North 56° 17' 30" West, a distance of 280.95 feet; thence North 33° 34' 23" East, a distance of 145.00 feet to the Southerly Right-of-Way line of Summer Street; thence South 56° 17' 30" East, along the said Southerly Right-of-Way line, a distance of 20.00 feet to the point of beginning, containing 0.186 acres, more or less, all in the City of Hammond, Lake County, Indiana

and, therefore, the aforementioned 20 foot portion of Alley is hereby vacated, subject to easements for existing water, sewer, gas, telecommunications, and utilities in place and adjoining lots within the Belaj's Addition are extended by operation of law to include the proportionate part of Alley hereby vacated.

BE IT FURTHER ORDAINED that the Ordinance herein shall have full force and effect from and after Public Hearing hereon, passage and approval by the Common Council of the City of Hammond, Lake County, Indiana, signed by the President thereof, and the approval and signing by the Mayor. The Clerk shall furnish a copy of this Ordinance to the County Recorder for recording and to the County Auditor.
