AN ORDINANCE CREATING A NEW FUND (FUND #265) FOR CORONAVIRUS RELIEF FUNDS VIA THE CORONAVIRUS AID, RELIEF, AND ECONOMIC SECURITY ACT (CARES ACT)

WHEREAS, the State of Indiana has received a direct distribution of Coronavirus Relief Funds from the United States Treasury that may be used for the limited purposes set forth in section 601(a) of the Social Security Act, as added by section 5001 of the Coronavirus Aid, Relief, and Economic Security Act (CARES Act); and

WHEREAS; the Indiana Finance Authority (IFA) is the administrative body responsible for the Coronavirus Relief Fund Program, whereby the CARES Act funds are distributed to a political subdivision with necessary expenditures incurred due to the public health emergency with respect to COVID-19; and

WHEREAS, the City of Hammond is the recipient of these CARES Act reimbursement funds and requires a dedicated fund to receipt and disburse this allocation of grant money; and

WHEREAS, the City of Hammond must now have a new fund established for receipt and distribution of these funds; and

WHEREAS, Megan Flores, City Controller, requests that a new account, number 265, be dedicated and created for the City of Hammond for purposes of accessing funds for the Coronavirus Relief Fund Program via the CARES Act with the Revenue and Budget Accounts for Fund 265 attached (Exhibit A); and

WHEREAS, the creation of this fund is not an additional appropriation and a public hearing is not required;
