ORDINANCE NO. 9517

AN ORDINANCE AMENDING ORDINANCE NUMBERS 7598, 8348, 8753, 9161, AND 9357, ALSO KNOWN AS SECTION 93.005 OF THE HAMMOND MUNICIPAL CODE, PERTAINING TO AMBULANCE USERS FEES TO INCREASE LOADED MILEAGE RATE

WHEREAS, the City of Hammond presently controls Ambulance Users Fees as set forth under Section 93.005 of the Hammond Municipal Code; and

WHEREAS, the cost of fuel and equipment has increased the cost to the Hammond Fire Department for loaded ambulance transportation; and

WHEREAS, the City of Hammond is now seeking reimbursement for mileage for loaded Ambulance transports at the permitted rate of Seventeen Dollars and Fifty Cents (\$17.50) per mile; and

WHEREAS, this Ordinance is an amendment to the Fees section of 93.005, specifically §93.005(A)(5), and does not amend or alter any other rate or provision of that Section of the Hammond Municipal Code; and

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond, Indiana that Ordinance Number 7598, 8348, 8753, 9161, and 9357, the same being known as Section 93.005 of the Hammond Municipal Code is amended to alter §93.005(A)(5) as follows:

Section 93.005 AMBULANCE USERS FEE.

(A) Fees

(5) The mileage fee for a loaded Ambulance being used to transport any person shall be Seventeen Dollars and Fifty Cents (\$17.50) per mile from place of pick up to medical destination.

THEREFORE, BE IT FURTHER ORDAINED that if any part of this ordinance shall be held invalid by a court of competent jurisdiction, the remainder thereof shall not be affected.

BE IT FURTHER ORDAINED this Ordinance shall be considered as amending Section 93.005 of the Hammond Municipal Code as to the issue of reimbursement for loaded mileage, and if there be any conflict therewith with any other section, this Amended ordinance shall take precedence.

BE IT FURTHER ORDAINED by the Common Council that this Ordinance shall be in full force and effect from and after its passage by the Common Council, signing by the President thereof, and approval by the Mayor.
