ORDINANCE NO. 9530

AN ORDINANCE CREATING A NEW FUND (FUND #297) FOR FY2022 LAKE COUNTY DRUNK DRIVING TASK FORCE GRANT FUNDS

WHEREAS, the Indiana Criminal Justice Institute (ICJI) has funded a 2022 Lake County Drunk Driving Task Force grant which offers monies to law enforcement agencies for the purpose of preventing drunk driving injuries and fatalities; and

WHEREAS, the 2022 Lake County Drunk Driving Task Force grant has awarded the City of Hammond Police Department \$80,000 in funds; and

WHEREAS, the City of Hammond Police Department requires the use of these monies received from the 2022 Lake County Drunk Driving Task Force which requires a dedicated fund to receipt and disburse this allocation of grant money; and

WHEREAS, the City of Hammond must now have a new fund established for receipt and distribution of these funds; and

WHEREAS, Megan Flores, City Controller, requests that a new account, number 297, be dedicated and created for the City of Hammond for purposes of accessing funds for the FY2022 Lake County Drunk Driving Task Force Grant with the Revenue Account being 297-331.00 and the Budget Accounts being 297-411.02-201 OT and 297-413.01-201 FICA; and

WHEREAS, the creation of this fund is not an additional appropriation and a public hearing is not required;

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond that the Hammond City Controller be and is authorized to provide, dedicate, and create a new account for the City of Hammond as follows:




