ORDINANCE NO. 9549

**AN ORDINANCE CREATING A NEW FUND (FUND #4409) KNOWN AS THE
HAMMOND POLICE CAPITAL EQUIPMENT FUND**

WHEREAS, on September 6, 2021, the Hammond Board of Public Works and Safety adopted the Capital Asset Accounting Policy to ensure the uniform understanding of the City's guidelines on capitalization and corresponding depreciation of assets; and

WHEREAS, the Hammond Police Department purchases equipment that qualifies as capital assets as defined in the Hammond Capital Asset Accounting Policy; and

WHEREAS, the State Board of Accounts has recommended the creation of a Police Capital Equipment Fund for the purchase of said qualifying capital equipment; and

WHEREAS, Indiana Code 36-1-3 authorizes the Common Council of the City of Hammond to create, by ordinance, a home rule fund necessary to effectively operate the City; and

WHEREAS, the creation of this fund is not an additional appropriation and a public hearing is not required; and

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond that the Hammond City Controller be and is authorized to provide, dedicate, and create a new account for the City of Hammond as follows:

City of Hammond #4409 Police Capital Equipment Fund


BE IT FURTHER ORDAINED by the Common Council that Fund #4409 be classified as non-reverting and funded via interfund transfers, donations, and miscellaneous reimbursements, with the Fund balance transferred into the General Fund upon its termination.




