**AN ORDINANCE CREATING NEW FUND (FUND #2471) FOR THE CITY OF  
HAMMOND FIRE DEPARTMENT FOR FY2023 INFRASTRUCTURE TRAINING  
GRANT FUNDS**

WHEREAS, the Indiana Department of Homeland Security offers local community grants that can be used for training, exercises, planning, personnel, and equipment to prepare for many threats and hazards; and

WHEREAS, the Hammond Fire Department is the recipient of a 2023 Infrastructure Training Grant for the purpose of purchasing a 12'16' adjustable pitch roof prop; and

WHEREAS, the City of Hammond must now have a new fund established for receipt and distribution of these funds; and

WHEREAS, the City Controller requests that a new account, number 2471, be dedicated and created for the City of Hammond Fire Department for purposes of accessing funds for the 2023 Infrastructure Training Grant with Revenue Account line item being 331.00 and Budget Account line item being 445.00 (Capital Outlay-Equipment); and

WHEREAS, the creation of this fund is not an additional appropriation and a public hearing is not required;


NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond that the Hammond City Controller be and is authorized to provide, dedicate, and create a new account for the City of Hammond as follows:


