**AN ORDINANCE CREATING A NEW FUND (FUND #2472) FOR THE CITY OF  
HAMMOND POLICE DEPARTMENT FOR FY2023 STOP ARM VIOLATION  
ENFORCEMENT (SAVE) GRANT FUNDS**

WHEREAS, the Indiana Criminal Justice Institute has funded a 2023 Stop Arm Violation Enforcement (SAVE) Grant, which is allocated to the Hammond Police Department for the purpose of providing assistance in the safe transportation of school age pedestrians at school bus locations; and

WHEREAS, the Hammond Police Department is a recipient of the 2023 SAVE Grant in the amount of Thirty Thousand Dollars and requires a dedicated fund to receipt and disburse this grant money; and

WHEREAS, the City of Hammond must now have a new fund established for receipt and distribution of these funds; and

WHEREAS, the City Controller requests that a new account, number 2472, be dedicated and created for the City of Hammond Police Department for purposes of accessing funds for the 2023 SAVE Grant; and

WHEREAS, the creation of this fund is not an additional appropriation and a public hearing is not required;

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond that the Hammond City Controller be and is authorized to provide, dedicate, and create a new account for the City of Hammond as follows:
