AN ORDINANCE CREATING A NEW FUND (FUND #2473) FOR FY2023 LAKE COUNTY DRUNK DRIVING TASK FORCE GRANT FUNDS

WHEREAS, the Indiana Criminal Justice Institute (ICJI) has funded a 2023 Lake County Drunk Driving Task Force grant which offers monies to law enforcement agencies for the purpose of preventing drunk driving injuries and fatalities; and

WHEREAS, the 2023 Lake County Drunk Driving Task Force grant has awarded the City of Hammond Police Department Eighty Thousand Dollars in funds; and

WHEREAS, the City of Hammond Police Department requires the use of these monies received from the 2023 Lake County Drunk Driving Task Force which requires a dedicated fund to receipt and disburse this allocation of grant money; and

WHEREAS, the City of Hammond must now have a new fund established for receipt and distribution of these funds; and

WHEREAS, the City Controller requests that a new account, number 2473, be dedicated and created for the City of Hammond for purposes of accessing funds for the FY2023 Lake County Drunk Driving Task Force Grant; and

WHEREAS, the creation of this fund is not an additional appropriation and a public hearing is not required;

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond that the Hammond City Controller be and is authorized to provide, dedicate, and create a new account for the City of Hammond as follows:
