AN ORDINANCE VACATING AN APPROXIMATELY 1242 FOOT PORTION OF STREET IN THE 2700-2800 BLOCKS OF EGGERS AVENUE AND ELDER AVENUE, AN APPROXIMATELY 488 PORTION OF STREET IN THE 1400 BLOCK OF 127TH AND 128TH STREETS AND AN APPROXIMATELY 1242 PORTION OF A NORTH-SOUTH ALLEY IN THE 2700-2800 BLOCKS BETWEEN EGGERS AND ELDER AVENUES. IN THE CITY OF HAMMOND, LAKE COUNTY, INDIANA.

WHEREAS, City of Hammond Department of Redevelopment is the fee simple owner of the following described real estate, to wit:

WHEREAS, City of Hammond Department of Redevelopment has filed a Petition for Vacation of a said Streets and Alley with the Common Council of the City of Hammond, Lake County, Indiana, requesting vacation of said 1242 foot portions of Eggers and Elder Avenues, said 488 foot portions of 127th and 128th Streets, and said 1242 foot portion of the North-South alley between Eggers and Elder Avenues; and

WHEREAS, the Common Council of the City of Hammond, Lake County, Indiana upon investigation and Public Hearing in accordance with applicable law, finds and determines that the proposed vacation will not hinder the growth or orderly development of the City of Hammond, Lake County, Indiana, or the neighborhood in which it is located or to which it is contiguous; and

WHEREAS, the vacation will not make access to the lands of any persons by means of public way difficult to inconvenient; and

WHEREAS, the vacation would not hinder the public's access to a church, school, or other public building or place; and

WHEREAS, the vacation will not hinder the use of a public way by the neighborhood in which it is located or to which it is contiguous.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF HAMMOND, LAKE COUNTY, INDIANA, THAT it is desired and deemed necessary to vacate the 1242 foot portions of Eggers and Elder Avenues, the 488 foot portions of 127th and 128th Streets, and the 1242 foot portion of the North-South alley between Eggers and Elder Avenues located in the 2700-2800 blocks of Eggers and Elder Avenues and the 1400 block of 127th and 128th Streets in the City of Hammond, and more particularly described as follows:

and, therefore, the aforementioned 1242 foot portions of Eggers and Elder Avenues, said 488 foot portion of 127th and 128th Streets, and 1242 foot portion of the North-South alley between Eggers and Elder Avenues are hereby vacated, not subject to easements, for existing water, sewer, gas, telecommunications, and utilities in place and adjoining lots within the Wilcox First Addition are extended by operation of law to include the proportionate part of Eggers Avenue, Elder Avenue, 127th Street, 128th Street and the North-South alley between Eggers and Elder Avenues hereby vacated.

BE IT FURTHER ORDAINED that the Ordinance herein shall have full force and effect from and after Public Hearing hereon, passage and approval by the Common Council of the City of Hammond, Lake County, Indiana, signed by the President thereof, and the

approval and signing by the Mayor. The Clerk shall furnish a copy of this Ordinance to the County Recorder for recording and to the County Auditor.

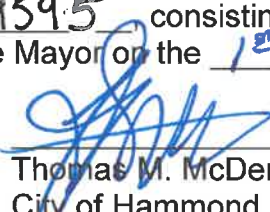

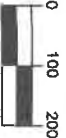

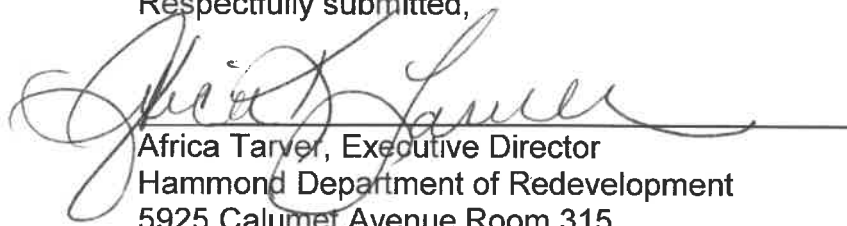
