AN ORDINACE RESPECTING AND RATIFYING THE ACTIONS OF THE CITY OF HAMMOND BOARD OF PUBLIC WORKS AND SAFETY RELATED TO TRAFFIC REGULATION FOR 2022

WHEREAS, there is established within the City of Hammond a Board of Public Works and Safety, created pursuant to Indiana Code 36-4-9-5 and City of Hammond Ordinance Section 34.065; and

WHEREFORE, the City Council through Ordinance No. 9545 transferred certain powers to the Board of Public Works and Safety regarding traffic regulations throughout the City of Hammond; and

WHEREFROE, during 2022 the Board of Public Works and Safety, in response to requests from city residents, businesses, departments of the city, and the City Council, and pursuant to Ordinance No. 9545 acted and regulated certain traffic matters throughout the city; and

WHEREFORE, these actions were efficient and affirmed the City Council's desire to shift these responsibilities as needed to the Board of Public Works and Safety; and

WHEREFORE, the City Council wishes to ratify those actions so that the traffic schedules within the city records can be updated and to officially recognize the actions of the Board of Public Works and Safety taken during 2022; and
