ORDINANCE NO. 9637

AN ORDINANCE CREATING NEW FUNDS (FUND NO. 3393 & FUND NO. 3395) TO FACILITATE THE 2024 FIREHOUSE PROJECT BOND

WHEREAS, on February 12, 2024, the Hammond Common Council passed Ordinance No. 9627 authorizing the issuance of bonds to finance the costs of a new fire station in the City of Hammond and appropriating the proceeds derived from the sale of such bonds; and

WHEREAS, the City of Hammond requires the use of these monies received from such bonds which requires dedicated funds to receipt and disburse this allocation; and

WHEREAS, the City of Hammond must now have new funds established for receipt and distribution of these funds; and

WHEREAS, the City Controller, requests that new accounts be dedicated and created for the City of Hammond for purposes of accessing funds for the facilitation of the 2024 Firehouse Project Bond; and

WHEREAS, the creation of these funds are not an additional appropriation and a public hearing is not required;

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond that the Hammond City Controller be and is authorized to provide, dedicate, and create new accounts for the City of Hammond as follows:






