WHEREAS, the Office of Community Oriented Policing Services (COPS), a division of the U.S. Department of Justice, administers the COPS Office Technology and Equipment program which provides grants to state and local entities to develop and acquire effective equipment, technologies, and interoperable communications that assist in responding to and preventing crime; and

WHEREAS, after successful application to the program, COPS has awarded the City of Hammond Police Department \$350,000.00 for FY2024 for the purpose of increasing community policing capacity and crime prevention efforts with the City of Hammond; and

WHEREAS, the City of Hammond Police Department requires the use of these monies received from the COPS Office Technology and Equipment program which requires a dedicated fund to receipt and disburse this allocation of grant money; and

WHEREAS, the City of Hammond must now have a new fund established for receipt and distribution of these funds; and

WHEREAS, the City Controller requests that a new account be dedicated and created for the City of Hammond for purposes of accessing these funds; and

WHEREAS, the creation of this fund is not an additional appropriation and a public hearing is not required;
