ORDINANCE NO. 9659

AN ORDINACE RESPECTING AND RATIFYING THE ACTIONS OF THE CITY OF HAMMOND BOARD OF PUBLIC WORKS AND SAFETY RELATED TO TRAFFIC REGULATION FOR 2024

- 1. The prefatory statements set forth above are incorporated as it fully set forth herein;
- 2. That the following actions taken by the Board of Public Works and Safety pursuant to Ordinance No. 9545 are ratified and approved:

Stop Intersections - Chapter 76 Schedule VI

2-way Stop signs

2-way stop controlled intersection

Eastbound and Westbound Cleveland Street and Garfield Ave.

Resident Only Parking Areas - Chapter 77 Schedule VII

2300 Block of 167th St. 2800 block of 163rd Place

Prohibited Parking - Chapter 77 Schedule V

No parking on this Side – west side Linden to 174th

3. That the City Clerk's office is ordered to itself and/or through the publisher to update the Traffic Schedules to reflect these actions.

BE IT FURTHER ORDAINED by the Common Council, that this Ordinance shall be in full force and effect upon signing by the President of the Common Council and approval by the Mayor, and Publication as provided by law.
