AN ORDINANCE RECLASSIFYING CERTAIN LANDS IN THE CITY OF HAMMOND FOR ZONING PURPOSES AND AMENDING ORDINANCE NO. 8514 (AN ORDINANCE ESTABLISHING A ZONING PLAN FOR THE CITY OF HAMMOND INCLUDING THE REGULATIONS AND MAPS TO ADMINISTER THE ZONING PLAN IN ORDER TO PROVIDE FOR ORDERLY GROWTH AND DEVELOPMENT WITHIN THE CITY, ALL IN ACCORDANCE WITH THE COMPREHENSIVE/LAND USE PLAN, AS AMENDED) FOR PROPERTY COMMONLY KNOWN AS 5911-5971 Noble Avenue, 5919-5963 Ray Avenue. and 1339 Highland Street

R-2 One and Two Family Residential District (Parcel 2), and R-1U Urban Single
Family Residential District (Parcel 3), and from class S-1 Open Space and
Recreational Facilities District and R-1U Urban Single Family Residential District to
S-1 Open Space and Recreational Facilities District (Parcel 4) is more consistent with
the surrounding zoning and prospective uses in the area.
