ORDINANCE NO. 9671

**AN ORDINANCE CREATING NEW FUND (FUND #2491) FOR THE ENERGY EFFICIENCY AND CONSERVATION BLOCK GRANT (EECBG) PROGRAM**

WHEREAS, the City of Hammond applied and was awarded grant funds by the Department of Energy (DOE) through the Energy Efficiency and Conservation Block Grant (EECBG) Program for the purpose of improving energy efficiency and reducing energy consumption; and

WHEREAS, the City of Hammond is the recipient of EECBG program funds in the amount of One Hundred and Thirty-Three Thousand Dollars (\$133,000.00) and requires a dedicated fund to receipt and disburse this allocation of grant money; and

WHEREAS, the City Controller requests that a new account be dedicated and created for the City of Hammond for the purpose of accessing funds from the EECBG program; and

WHEREAS, the creation of these funds is not an additional appropriation and a public hearing is not required; and

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond that the Hammond City Controller be and is authorized to provide, dedicate, and create a new account for the City of Hammond as follows:




