ORDINANCE NO. 9678

**AN ORDINANCE CREATING NEW FUND (FUND #2492) FOR JUSTICE ASSISTANCE GRANT (JAG) PROGRAM FUNDS AWARDED TO THE CITY OF HAMMOND POLICE DEPARTMENT**

WHEREAS, the Edward Byrne Justice Assistance Grant (JAG) Program, administered by the Bureau of Justice Assistance (BJA) provides states, territories, tribes, and local governments with critical funding necessary to support a range of law enforcement program areas; and

WHEREAS, the BJA has awarded the City of Hammond Police Department reimbursable JAG funds for FY2024 in the amount of \$36,267.66; and

WHEREAS, the City of Hammond Police Department requires the use of this FY2024 JAG grant award which necessitates a dedicated fund to receipt and disburse this allocation of funds; and

WHEREAS, the City of Hammond must now have a new fund established for receipt and distribution of said funds; and

WHEREAS, the City Controller requests that a new account be dedicated and created for the City of Hammond for purposes of accessing funds for the FY2024 JAG Program; and

WHEREAS, the creation of these funds are not additional appropriations and a public hearing is not required;

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond that the Hammond City Controller be and is authorized to provide, dedicate, and create a new account for the City of Hammond as follows:






