ORDINANCE NO. 9681

AN ORDINANCE DESIGNATING NEW FUNDS (FUND #2249 AND FUND #2250) FOR THE MUNICIPAL EXCISE TAX AND CONCURRENT WHEEL TAX FUNDS

WHEREAS, on October 15, 2024, the Hammond Common Council adopted and approved Ordinance No. 9643 for the purpose of adopting a municipal excise tax and concurrent wheel tax, pursuant to Indiana Codes 6-3.5-10 et seq. and 6-3.5-11 et seq; and

WHEREAS, within Ordinance No. 9643 a City of Hammond Municipal Surtax Fund and City of Hammond Wheel Tax Fund were created in which revenue generated from the wheel tax and excise tax shall be deposited; and

WHEREAS, the City of Hammond must now designate new funds established for receipt and distribution of these funds; and

WHEREAS, the City Controller, requests that new accounts be dedicated for the City of Hammond for purposes of accessing funds for the Hammond wheel tax and municipal excise tax; and

WHEREAS, the creation of these funds is not an additional appropriation and a public hearing is not required; and

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond that the Hammond City Controller be and is authorized to provide and dedicate new accounts for the City of Hammond in the following categories:

Fund No. 2249 - Wheel Tax Distribution
Fund No. 2250 - Surtax Distribution






